The value of newly signed contracts of the Company from January to December 2025 amounted to RMB1,113.6 billion, representing a decrease of 10.8% from the same period of last year. Among them, the value of newly signed overseas contracts amounted to RMB94.88 billion, representing an increase of 1.9% from the same period of last year.
